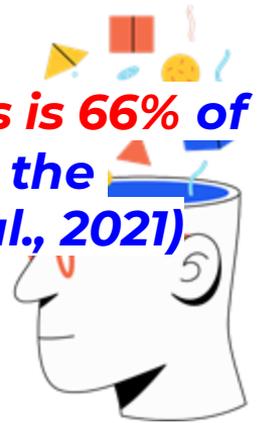
Context of this Study



Over 1.6 billion school children globally were shut out of school at the height of the pandemic (Thompson, 2022)

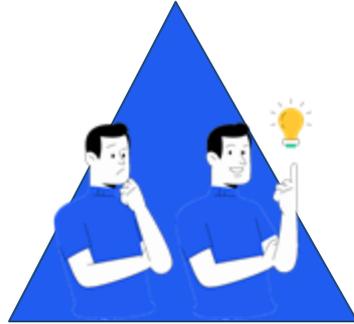
Transition to various modality of distance education

Learner's average learning loss is 66% of previous learning gains during the transition phases (Sabates et al., 2021)

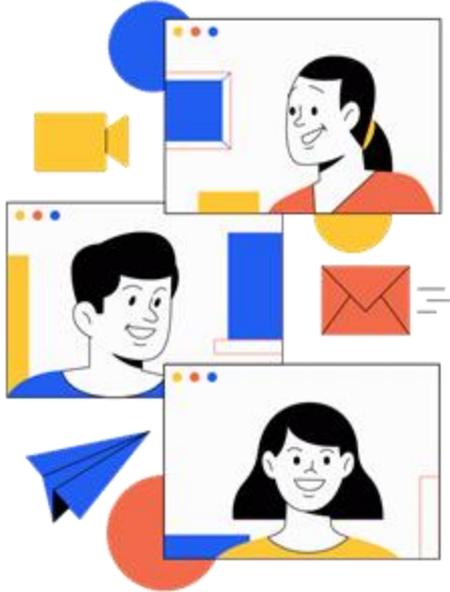

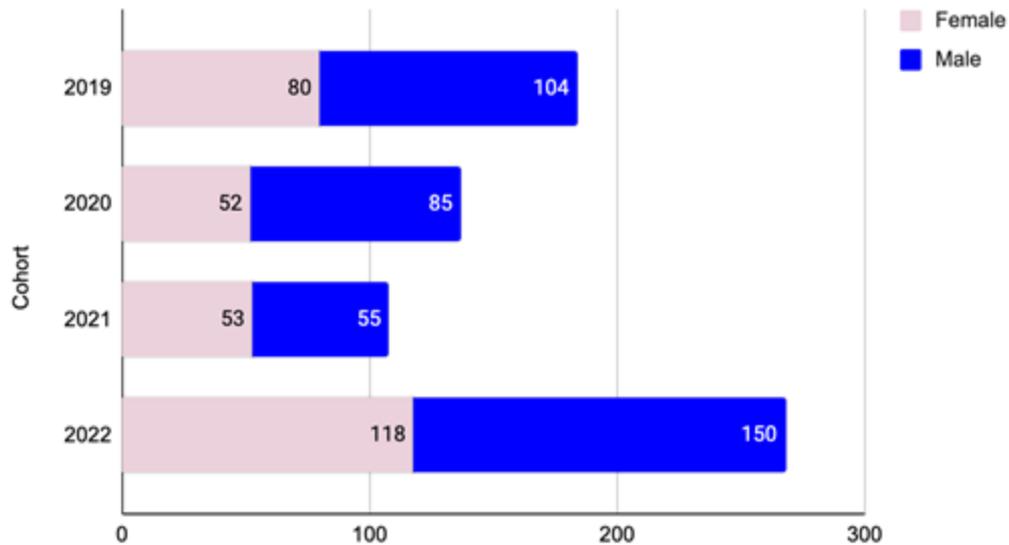

Research Findings

1. Establish the profile of the graduates from 2019 to 2022.

Chart 1. Gender Distribution in Each Cohort (n=697)

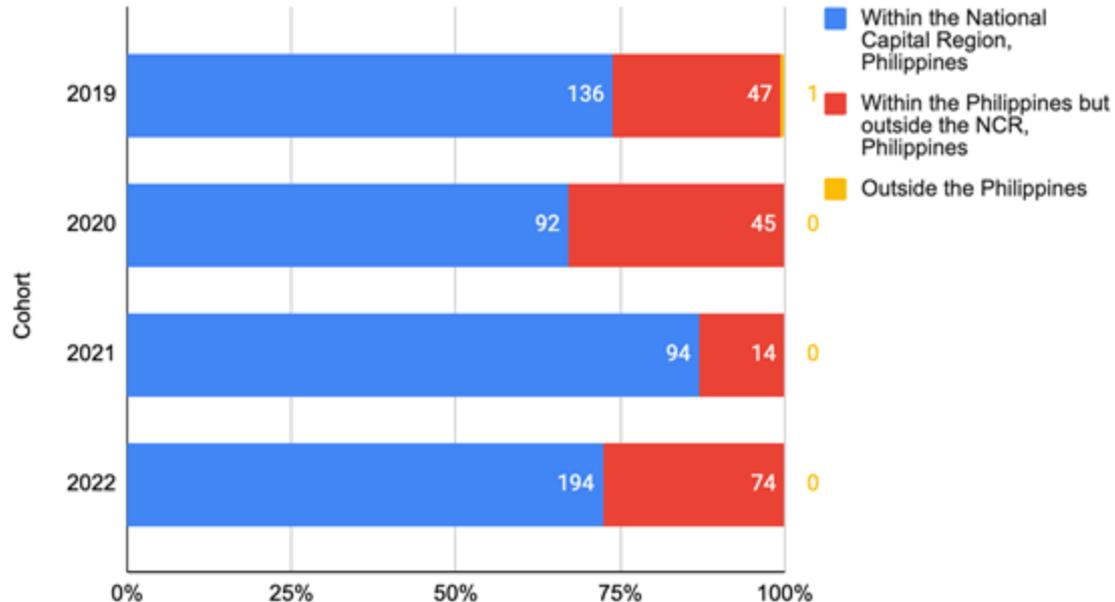


- **Majority of the graduates are male;**
- Gender is **positively correlated** to the length of course completion, $r = 0.236$, $p = 0.001 < 0.05$;
- There is a **significant difference** between the course completion of the graduates once grouped based on their gender, $z = 5.002$, $p = 0.027 < 0.05$.

Research Findings

1. Establish the profile of the graduates from 2019 to 2022.

Chart 2. Residency Distribution in each Cohort (n=697)

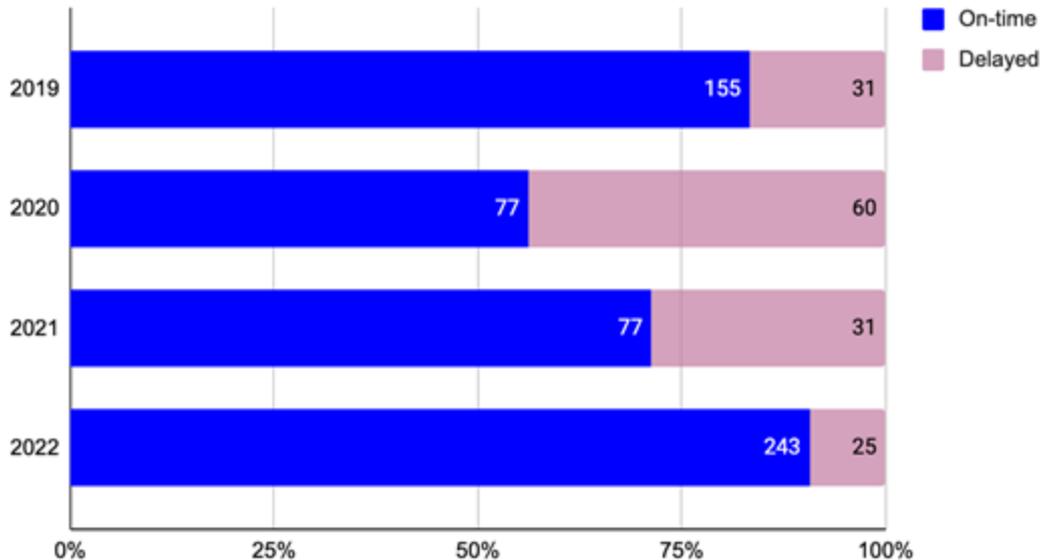


- Majority of the graduates are resident within the NCR;
- Learner's residence is positively correlated to their course completion ($r = 0.105, p = 0.006 < 0.05$); and
- There is a significant difference in the course completion of the graduates once grouped according to their residency, $F(2, 692) = 3.914, p = 0.020 < 0.05$.

Research Findings

2. Establish the timeliness learners' course completion.

Chart 3. Timeliness of Course Completion (n=697)

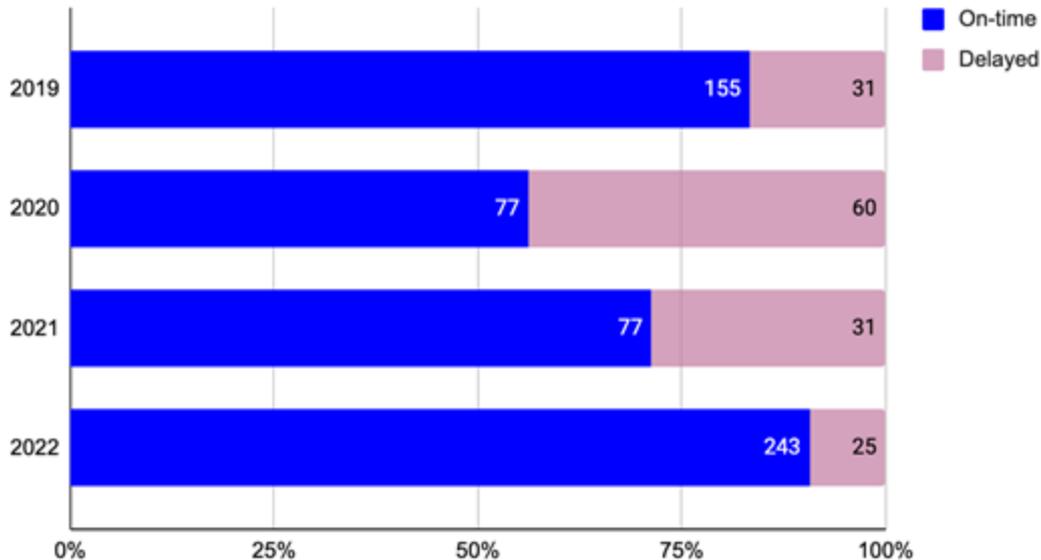


- Overall, **79%** of the graduates were able to complete their course program on-time. Meanwhile, **21%** of the graduates were delayed due to various reasons;

Chart 3. Timeliness of Course Completion (n=697)

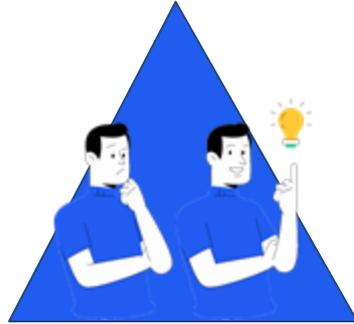


- An overall mean of **3.72 years with a standard deviation of 1.09 for learners** to complete their respective course programs.

Recommendations

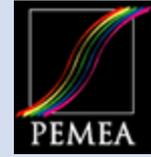
- Investigation on the impact of the learning modality for **graduates** in regard to **gained competencies and skills**;
- **Revisitation** of the existing institutional policies and guidelines for **admission and monitoring the learner's course completion** could be carried out.
- Integration of **Artificial Intelligence Framework** in the daily operations of concerned offices.

 - Curating a long-term mental-health program
 - Improving the course offering
